


Office of Financial Planning & Analysis F&A Summary Report Fiscal Period: July 1, 2021 through June 30, 2022 Current Period: October 31, 2021

Key Data Points


- As of October FY2022, Modified Total Direct Cost base research spending was \$98.4M, up from \$87.3M or 12.7% in October FY2021. (See comparision table page 4 and base graph page 2)
- Modified Total Direct Cost YTD spending on grants with the current 61.5% F&A rate was \$53.2M which generated \$32.5M in F&A recoveries. (See YTD information table page 4)
- F&A recoveries were \$40.5M as of October FY2022 (up 13.5% from prior period FY2021), \$4.8M more than the \$35.7M recovered for the same period in FY2021. (See comparision table page 4)
- The effective rate as of October YTD FY2022 was 41.2%, up from 40.9% in October FY2021. (See comparision table page 4)
- We projected a 2.85% increase in F&A for FY2022 based on FY2021 actual F&A recovered. The full year projection for FY2022 totaled \$96.7M.

FY2022 Base by School October 31, 2021 YTD







